Rules of participation sailing camp from March 2023 (please do not print)

First read - then set sail. Before registration, the participant rules for the sailing program must be read carefully. These must be accepted for registration and/or participation!

Requirementes for the trial sailing!

The sailing camp is basically open to everyone.

- Each participant must have at least the bronze swimming badge, except for the trips when an authorized person or a teacher is on board.
- The age limits for the individual sailing courses and offers must be observed.
- All participants must have the permission of their legal guardians as long as they are not yet of age. Class teachers or group leaders have to take care of this and accompany their group.

The following documents must be observed:

- Declaration of consent for participation in the sailing program to be handed in at the counter at the sailing camp.
- List of names: for groups with more than 4 persons
- Disclaimer: for participants in certain courses without the bronze swimming badge.
- Good to know: All information for a good course flow

Sailing is better when you are healthy!

• The general health condition of each participant must allow the water sport and he/she must not suffer from seizure diseases, such as epilepsy. In case of slight health restrictions (e.g. asthma) of the participant, this information and, if necessary, the special treatment/observance must be communicated in writing and in detail by the parents, legal guardians, teachers or group leaders to the sailing camp (especially the sailing coaches).

Persons with symptoms of an infectious disease, especially Covid-19, are not allowed to participate in the course and are not allowed to enter the sailing camp area.

- The necessary medication must be carried by the participant during the entire course. The participant should introduce him/herself to the respective sailing trainer in a personal interview in time before the course starts.
- If the participant does not wish to participate in one or more program points for health or other reasons, this must be communicated in writing to Kiel Marketing GmbH in good time before the start of the course.
- With the registration for the program, a bathing permit is also granted for the participant.
- Any form of alcohol consumption or other intoxicants is prohibited. Alcoholized persons are not allowed to enter the sailing camp area, the jetties and the boats.
- Healthy arrives: The sailing camp is generally a smoke-free area, except for special events. This smoking ban also applies on board the boats.

Safety arrives!

- For safety reasons, it may be necessary at any time to cancel or limit the course or change the program. This applies especially in case of danger of fog, storm or thunderstorm. Since the weather situation cannot be influenced, no course fees or other costs can be refunded for cancelled time.
- The participants will be supervised by the staff of the sailing camp for the duration of the course. Unless an earlier end is agreed upon in consultation with the parents or guardians or group leaders.
- The situation may require that a group is divided during the course (e.g. into a theory and a practice group) and thus, for example, no simultaneous, joint sailing is possible. This can be the case, for example, with the sailing cutter trips from a number of participants of 24 people.
- In certain wind and weather conditions it can happen that the engine is used instead of the sail. We ask for your understanding for this.
- Solid/life jackets will be provided for everyone and must be donned before entering the dock and worn at all times on the







water

- The leading sailing trainers of the sailing camp are highly qualified. They have the legally required qualifications and extensive experience in the field of sailing education.
- 1st aid equipment is extensively available and appropriately marked on shore: They are located, among others, in the reception tent (10x10pagoda) on the premises of the sailing camp. In addition, 1st aid kits are available on all boats. Please contact the sailing camp staff if needed.

Well insured/our liability!

- The sailing camp has an insurance package with the Provinzial insurance. Part of this package is an organizer liability insurance and a boat liability insurance. The sailing camp is liable for personal injury and property damage within the scope of the existing insurance contracts.
- If the damage is not covered by the existing insurances, our liability for breach of contract and tort is limited to intent and gross negligence.
- This does not apply to injuries to the life, body and health of the participant, claims for breach of cardinal obligations, i.e. obligations arising from the nature of the contract and the breach of which endangers the achievement of the purpose of the contract, as well as compensation for damages caused by delay (§ 286 BGB). In this respect, we shall be liable for any degree of fault. Liability in the event of a breach of essential contractual obligations shall be limited to the regularly foreseeable damage.
- The aforementioned exclusion of liability shall also apply to slightly negligent breaches of duty by our vicarious agents.
- Insofar as liability for damages not based on injury to life, body and health of the participant is not excluded for slight negligence, such claims shall become statute-barred within one year, beginning with the accrual of the claim.
- The aforementioned limitations of liability also apply in the event of loss/damage to items that the participant has brought
 with him/her for the duration of the stay in our rooms. No liability can be accepted for the loss or damage of personal
 belongings. Therefore, please take good care of your belongings. At the beginning of the course, valuables can be left with
 the sailing instructors at your own risk. Tip: Do not take any valuables with you.
- We are not liable for accidents caused by the participants themselves. A self-inflicted accident can occur if a violation of the participation rules has become the cause of the damage.
- In the case of accidents for which the sailing camp is not responsible, there is usually insurance coverage through the appropriate social insurance carrier (e.g. statutory health or accident insurance). However, this is the responsibility of the participant, his/her legal representative, the school, clubs or other institutions. An additional accident insurance for the participants and guests has not been concluded by the organizer of the sailing camp. In this context, we would like to point out the conclusion of a corresponding safety/insurance package.

Payment, withdrawal and rebooking

- Payment is usually made in advance. The booking is only binding after payment, but Kiel-Marketing GmbH reserves the right to cancel courses if the minimum number of participants is not reached.
- You can withdraw at any time before the start of your booked course. However, Kiel-Marketing GmbH reserves the right to charge cancellation fees.







- The cancellation fees are per individual service to be provided by Kiel-Marketing GmbH from day 30 to the 14th day before the start of the course = 30%, from day 13 to day 6 = 50% of the course price, thereafter the cancellation fee is 100% of the course price or the price stated in the booking confirmation. These cancellation fees may also apply to group bookings for a lower, real number of participants than the number booked.
- In the event of a course cancellation by Kiel-Marketing GmbH due to an insufficient number of participants, the booker will be refunded 100% of the payment made.
- You are free to prove lower costs in any case. In order to avoid misunderstandings, the declaration of withdrawal must be made in writing by e-mail to info(at)segelcamp-kiel.de. The date of receipt of the declaration by Kiel-Marketing GmbH is decisive.

Media

- The sailing camp is in the positive, public interest and we understand sailing as a team sport, where we collect beautiful experiences together. It is therefore possible that photos, films or similar recordings are taken of the participants* in particularly good weather or beautiful moments at the sailing camp, in some cases also in group situations.
